ActionAid International Nepal - Introduction

ActionAid is a global federation working to achieve social justice, gender equality, and poverty eradication. ActionAid International Nepal (AAIN) is a member of the global federation of ActionAid, working for human rights, poverty eradication, and gender equality. It is a nongovernmental national social justice organization established in 1982 and working locally in different provinces of Nepal. It is also a part of both national and global social justice movements and other civil society networks, alliances, and coalitions.

Background and purpose of ToR

ActionAid International Nepal (AAIN) publishes an Annual Reflection and Learning Document (ARLD) each year to document and disseminate the results and impact of its work. The ARLD summarizes the program's accomplishments, lessons learned, and difficulties encountered, and is accessible to a wide range of audiences, from the national to the global level.

Therefore, AAIN needs to work with an independent consultant, to produce annual reflection and learning document. Based on the conditions set forth in these Terms of Reference, the consultant will work on a consultancy basis to deliver designated objectives within a specified timeline. The Organisational Impact and Communication Department (OIC) in AAIN will be entirely responsible for coordinating this task with the Consultant.

Objectives of the task

The overall objective of the present task is as follows:

- Desk review of available department reports and to identify key changes/outcomes suited for the report;
- Write up of ARLD 2022 based on the documentation and all relevant materials provided by AAIN focal person;
- Language editing and proof reading of the document;
- Sharing of the draft report with AAIN focal person for their inputs/review;
- Writing the executive summary for the report;
- Writing the ED/Board Chair's message;
- Incorporate comments/suggestions and finalise document; and
- Coordinate and sit with designer to finalize report in appropriate format ensuring full text and photographs (with caption) in place.

Process of the task

The AAIN focal person will provide relevant content for ARLD, which will then be reviewed and prepared by the consultant. As needed, the consultant will receive additional information from the AAIN focal person, where possible. Consultants and AAIN focal persons will coordinate closely.

Time period

The time period for this aforementioned task is expected to be of one and half months. The task will start from **24 February**, **2023** and the final document is expected by 10th April, **2023**. The schedule should be as per the details given below:
