Background CARE Nepal

CARE is an international NGO with local staff and community partners in more than 90 countries. We create local solutions to poverty and inequality and seek dignity for everyone every day and during times of crisis. CARE puts women and girls at the center of everything we do because they have proven to be the best hope for creating lasting change in the world. CARE has been operational in Nepal since 1978 and works in partnerships with government and non-government stakeholders across the spectrum of humanitarian action and long-term development programs.

Background information/context

Start Network is made up of more than 50 aid agencies across five continents, ranging from large international organizations to national NGOs. Together, our aim is to transform humanitarian action through innovation, fast funding, early action, and localization. Start Fund Nepal is a Start Network program hosted by CARE Nepal. In June 2021, with support from the UK Foreign Commonwealth and Development Office (FCDO), Start Fund Nepal was launched. The Start Fund Nepal Pilot is a collectively managed emergency financing mechanism, developed in Nepal by Start Network members and partner NGOs with support from Start Fund Nepal and the global Start Fund. The pilot project was completed in March 2022. Phase II of Start Fund Nepal began in April 2022 and will conclude in March 2024. Based on the global guideline, Start Fund Nepal also follows the 45 days implementation cycle, making funding decisions within 72 hours of a crisis alert, with awarded agencies starting project implementation in 7 days. It has 21 Members consisting of 15 Global Start Network members and 6 local and national NGOs. The Start Fund Nepal Committee is responsible for the strategic management and operations of the Start Fund Nepal Pilot within the parameters set by the global Start Fund Committee.

After successful completion of the pilot phase, the phase II started from April 2022 to March 2024. To capture our achievement and process as well as to showcase our work, we are planning to put the proper communication plan.

And as per the plan for this 1st year we are planning to carry out mainly following:

- Start Fund Nepal (SFN) Documentary covering both achievement and process
- Television and Radio Show Focusing KTM and outside KTM (most probably Gorkha and Terai districts)
- Case/Success studies, prepare photobooks
- Panel Discussions
- Social Media Campaign through twitter, webpage, Facebook, etc.

Objectives

- Capture our achievements and process documentation
- Highlight our strengths and challenges
- Showcase our learnings and Achievements

The consultant is expected to provide the consultancy services for capturing those events, conducting the discourse and showcasing in different forums and forms.

Methodology

- a. Desk Research and review on Start network as well as start fund programme, role of national, local government, development partners and other members
- b. Filming the different events, conduct an interview and conduct the discourse among members, community and government, donors of start fund to capture the learnings and challenges
- c. Report preparation and follow up.

- b. Advanced University Degree (Bachelor) in international development, media, journalism or a related discipline (For Consultant/s or Proposed personnel of Media House)

- d. Ability to produce quality report within deadline
