Background on Save the Children

Background information /context

Opioid Substitution Therapy (OST) program is currently running in 12 sites in 10 Districts (Annex 1: List of OST sites) for interaction) of Nepal under the leadership of NCASC. The Department of Narcotics Control under the Ministry of Home Affairs (MoHA) is the main regulating body of narcotic drugs in Nepal. The OST program in Nepal includes provision of Methadone or Buprenorphine to opioid drug users. This program aims to improve physical, mental, and social recovery of patients affected by opioid use disorder with stabilization of patients affected by opioid use disorder to allow reestablishment of a satisfying and rewarding life free of illicit opioid use. Provision of access of people affected by opioid dependence to OST has been declared a high priority by the government of Nepal.

Ministry of Home Affairs (MOHA) in collaboration and coordination with NCASC and SCI-GF has planned to develop one video to for general pulbic in terms of sensitization and increase awareness of harm reduction program (OST) implemented in Nepal and thus, improving the quality of life and health of injecting drug users.



Although OST program is implemented in Nepal since more than decade, its utilization is not satisfactory due to low coverage and less awareness about its effectiveness. With all these issues to be addressed, there is a need for one awareness creating video on current program of OST. Thus, this video development will be instrumental for enhancing the quality of life of injecting drug users with the use of OST.

<u>Objective</u>

The main objective of the consultancy is to develop video on OST

- 1. Prepare Script in Nepali Language and develop video on OST program to increase awareness on
 - benefits of OST,
 - clarify misconception on OST

Scope of work

The Scope of Work includes the following activities but not limited to.

- 1. Literature Review of Harm reduction and OST program in Nepal
- 2. Prepare script in Nepali Language for the video (maximum 5 mins) in consultation with NCASC, MOHA and SCI-GF and Network both OST service providers and OST taker, SCI Focal person, NCASC OST Focal person, MoHA Focal Person, NCB, Drug users (Male and Female)
- 3. Share the draft script to the above for review, feedback, finalization, and approval
- 4. Develop a video based on the approved script
- 5. Share the draft video with the above for review and feedback
- 6. Incorporate the feedback and share the final video for approval.

Technical Note:

- The video should be recorded in HD (preferably in 4K, but not mandatory).
- Use a proper camera with good video capabilities.
- Sound quality is crucial. Always use an external microphone close to the subject. For interviews a livelier mic will be preferable.
- Make it simple. Content is crucial.
- The tone of the video will be balanced and stay free of bias.
- All material should be shared not later than agreed upon date
