 - Understanding and management of sponsorship and its impact on children.

4. Local Rights Programme (LRP) 31 Overview

Local Rights Programme (LRP) 31, operational since 2014, is managed by local partners, with a scheduled closure date of December 31, 2024. Coverage area of the programme is communities from Laliguransh Municipality, Chhathar Rural Municipality and Athrai Rural Municipality of Terhathum district. The programme is primarily funded through individual supporters from various affiliate countries of ActionAid federation. It aligns with the Country Strategy Papers of ActionAid International Nepal (AIN), focusing on four priority areas:

- Advancing Women's Agency to combat violence against women and girls, and address gender-based inequalities.
- Enhancing Quality Public Education
- Promoting Sustainable Economic Alternatives

- Strengthening Resilience Against Disasters

The overarching mission is to promote social justice, equality, and poverty eradication. To achieve this, the programme targets systemic changes across four key aspects:

1. **Rights:** Ensure that state, corporate, and societal entities respect, protect, and fulfill the rights of People Living in Poverty (PLiP) and other marginalized communities. Foster civic responsibility and dignity in rights realization.
2. **Representation:** Ensure meaningful and systematic representation of PLiP in decision-making processes at all levels, aligning with the principle of "nothing about us without us." Note that while 'Representation' is integrated into all components of the framework, changes in this area are still monitored for historical alignment.
3. **Redistribution:** Enhance access to and ownership of resources for PLiP. This includes connectivity, information, knowledge, productive assets, and public services. Ensure equitable distribution of care work and financial resources.

4. **Alternative Building:** Develop and promote community-led, gender-responsive development initiatives. Utilize feminist research to generate evidence-based alternatives, influencing public policy and development priorities.
