Consultant Clinical coach for onsite Coaching for IUCD/Implant/SBA service providers

VSO is seeking to appoint a consultant for the onsite clinical coaching/mentoring to trained government service providers for IUCD,IMPLANT,SBA in different health facilities to improve quality and support on capacity of Health workforce on RMNH/IUCD/IMPLANT service in project district.

The contract will be for a period of 19 days.

Contract period: from 15th feb to 6th March 2022.

1. Introduction

VSO is an international development agency with over 60 years' experience of addressing poverty and marginalisation through our unique approach of working through international, national and community volunteers. By bringing together different perspectives and working at all levels of society – from communities to government ministries – volunteers can build trust and provide the right support to ensure that national development efforts deliver lasting change. Our works falls into the three thematic areas of Health, Education and Livelihoods.

In Nepal the average age at marriage is 17.9 for women and 21.7 for men. Young people aged 15-24 experience major life transitions, complicated by the harmful effects of gender inequality that render them vulnerable to poor health outcomes. During this period of life, young women are often forced to drop out of school, get married, and move to live with their new husband's family. They find themselves with limited social support; little to no knowledge about reproductive, maternal, and newborn health (RMNH); poor nutrition; few opportunities for financial gain; limited control of resources; and restricted mobility. Young couples quickly face gender-based expectations around household roles and pressure to bear children early and in rapid succession, which leads to higher risk of maternal and infant mortality and morbidity.

The purpose SYAHAAR – Strengthening Access to Adolescent Holistic Health Right, Project is to improve the sexual reproductive, maternal neonatal child health(SRMNACH) and well-being of all adolescent and youth (aged 10-24 years) throughout one of the most vulnerable periods of their lives viscous cycle of transition of adolescent, to marriage and parenthood. The overall outcome of project is to improve access to comprehensive inclusive quality (SRMNCAHR) health services for adolescents and youth through quality delivery and monitoring of health (SRMNCAHR) services, by supporting on capacity of the health workforce to deliver inclusive SRMNACH services inorder to support marginalized and vulnerable adolescent and youth to seek and utilize RMNH services, transform social norms around gender, unhealthy practices and create supportive environment .

The COVID-19 pandemic has exacerbated such pre-existing sexual and reproductive health issues in young people hindering effective delivery of sexual and reproductive health services. Due to the immense stress faced by the health system, the delivery of routine health services and information to young people is disrupted while sharply limiting their access to SRH services. Marginalized groups are doubly troubled due to stigma and discrimination that COVID-19 adds to already existing challenges in accessing sexual and reproductive health.

2. Objectives

Based on the background provided above, onsite coaching and mentoring contributes to improve access to comprehensive inclusive quality (SRMNCAHR) health services for adolescents and youth by supporting on capacity of the health workforce to deliver on inclusive SRMNACH service and envisions following objectives;

- To hire the consultant trainer for Onsite review and coaching ,mentoring at health facility level.
- To asses the FP service status, observe the process of Implant & IUCD service delivery by trained Health workers and identify the gaps and then provide on the spot coaching.
- To assess the normal delivery case status, referral, antenatal care, postnatal care and newborn care status of the health facility and KAP gap of the trained service providers.
- To assess the essential equipment, layout, preparation of service sets including infection and prevention measures status in health facility.
- To ensure the essential equipment have been in proper use and support to use them .

3. Scope

Under the responsibility and accountability of the Project Specialist - Adolescent Youth Sexual Reproductive Health, the consultant is expected to help facilitate the following tasks:

- Participation in a kick-off meeting with core team of VSO Nepal to discuss the terms of reference, methodology and orientation on the project, participants.
- Draft standard schedule merged two trainings and develop the checklists/ materials for practice-based sessions and demonstration.
- Asses the skills gaps of HWs and provide coaching in those area to improve the skills
- Provide onsite coaching to FP, safe motherhood service, neonatal care service providers of different health facilities in the project district
- Lead the process of onsite coaching and facilitate the onsite coaching process
- Facilitate practical session in real case at HFs and practice in demo if there is no real case available Write the training completion reports

4. Expected Deliverables

The consultant is expected to deliver the following outputs:

- Finaization of Detailed work plan, with milestones and timelines.
- Facilitate in acquiring necessary materials; like pelvic models, IUCD & IMPLAT set, arm model, normal delivery sets, dummy neonate and standard checklist etc.
- Facilitate for ensuring the basic PPE for self-protection and ensure use of PPE.
- HFs wise event completion Reports with data desegregate, details of coachee, number of service delivery in last month, The final report will be reviewed by VSO team for final approval.
- Action Oriented Photographs and attendance sheets of participants.

5. Time and level of effort

• The expected level of effort is estimated to max. 19 days(3 days each 5 health facilities-4 days preparation,travel and reporting).

6. Resources and budget available

Onsite coaching and mentoring will be conducted by 6th March 2022, in 5 Birthing center(hospital,PHC) of Bara and Rautahat.

7. Timeline and output

The onsite coaching and mentoring should be completed within 6th March 2022.
