AIN *Code of Conduct* is a set of fundamental & operational principles and standards to guide the actions and management of member organizations for improving the ethical values of its membership. All AIN Members benefit from the code of conduct as it systematically identifies ethical practices and acceptable standards. The adoption and internal enforcement of this Self- Regulation Mechanism not only provides an ethical check for AIN Members, it also serves as a statement to the beneficiaries, government, donors and the public that the INGO takes seriously the importance of maintaining high standards and it also forms the basis for self-certification of the INGOs.
